

Terms and Conditions on Free Share Campaign

1. Introduction

- 1. Capex.com is a brand name of Key Way Investment Ltd, investment firm licensed and regulated by the Cyprus Securities and Exchange Commission (<u>www.cysec.gov.cy</u>) under licence no. 292/16 (hereinafter the "Company").
